Why not research positive topics regarding locals and how knowing these families can foster appreciation of the Asian community outside Nevada County. We have/had actors, playwrights, grocers, professional health care workers, retail and laundry owners. All wonderful families. In fact, when I was still on the Grass Valley City Council, having just stepped down as mayor, we named a street in honor of our Asian American families. Tinloy Street. Our students should be researching that.

The topics listed for the contest are all negative and not one is directed to our historical Asian community or the fact we, as a society, have come a long way since importing Chinese laborers. Why aren't we teaching our students the truth: they live in a county full of good and decent people and they are citizens of a country that has provided more freedom and more opportunity to more humans than any country in history.

# Menstrual Equity at Clear Creek Elementary School

I recently attended a school board meeting of the tiny Clear Creek Elementary School District on McCourtney Road here in Nevada County. During the session a new policy came up for a vote to require that free menstrual products, both pads and tampons, be available in the girls', non gender, and at least one boys' restroom for all students grades 6-12. The policy, an administrative regulation coming down from the state, was unanimously approved by the board with no discussion. After the meeting I spoke with a mom who not only opposed this policy but also told me that the Parent Teacher Organization had requested \$300 to purchase Badminton equipment for the multipurpose room to provide a bad weather activity but was told there wasn't enough money to do that. She was reasonably very frustrated.

Obviously the school board was dealing with a transgender issue. I didn't ask if they had any transgender students, but that really didn't matter. According to the state it would be irrelevant. They simply must provide the tampons and pads in order to check off the box. If a girl wanted to be a boy, she/he had to be assisted in making that transition. She/he would be allowed to use the boys' restrooms and locker rooms. Boys who wanted to be girls would be allowed to use the girls' restrooms and locker rooms.

The issue of biological boys using girls' facilities has exploded with the media's attention to several rape cases across the country. One transgender male raped a girl in the girls' restroom at school. Because the boy claimed he/she was a girl the school district didn't disclose what had happened and simply transferred him/her to another high school instead of having him/her arrested. At that school he/she raped another girl. You may have heard of this case on television because one of the girl's fathers went to the school board meeting to lodge a complaint about his daughter's rape, but was violently taken down by the police. NewsMax at least reported on this.

From Sarah Lindblom concerning the Chicago Park School board minutes of 3-9-23: The Board discussed Menstrual Equity and came to the conclusion to comply to avoid a lawsuit as they discovered COULD happen. They also discussed SEL, "pros and cons" and decided to "continue status quo".
